Speakers Biographies

(Natalie de Vito

Natalie relocated to Tasmania from Canada to establish the Junction Arts Festival. She has worked for over 15 years across visual arts, theatre and live performance developing over 100 performances and events in over 20 countries. She was formerly Artistic Producer of Mammalian Diving Reflex and Deputy Commissioner for Canada at the 2009 Venice Biennale.

2 Matthew Gordon

Matthew is co-founder and director of OurSay, Australia's largest e-democracy platform. OurSay has worked with the Prime Minister's office, Department of Foreign Affairs and Trade, Centre for New Public Education, Local Government Councils, Our Community and Department of Families, Community Service and Indigenous Affairs. Matthew is a fellow at the Centre for Sustainability Leadership.

(3) Nicholas Gruen

Nicholas is a widely published policy economist, entrepreneur and commentator with a column in The Age and Sydney Morning Herald. He has advised Cabinet Ministers, sat on Australia's Productivity Commission and founded Lateral Economics and Peach Financial. He chairs the Australian Centre for Social Innovation and in 2009 he chaired Australia's internationally acclaimed Government 2.0 Taskforce.

(4) Lisa Havilah

Lisa is the Director of Carriageworks, Sydney which produces and presents a contemporary multi-arts program. From 2005 – 2011 Lisa was the Director of Campbelltown Arts Centre which, under her directorship, pioneered a multidisciplinary contemporary arts program, bringing together artists and communities across disciplines to examine ideas through the processes of producing contemporary art.

5 Jee Hyun Kim Ph.D.

Dr Kim leads a research team working on memory aspects of anxiety disorders and drug addiction in the Florey Institute of Neuroscience and Mental Health, University of Melbourne. Her research suggests cognitive-behavioural therapies have different effectiveness depending on one's age, and advocates treatment of mental disorders during childhood. Her national and international interdisciplinary collaborations currently involve eight different laboratories.

6 Deborah Leiser-Moore

Deborah is a contemporary performance maker, an 'activator' who is passionate about bringing artists together to create discussion, collaborations and forge a positive arts community. She is Artistic Director of Tashmadada and has toured nationally and internationally as well as studied with Tadashi Suzuki and trained in the work of Ettiene Decroux.

(7) Chris Mead

Chris is Literary Director of Melbourne Theatre Company. Previous positions include artistic director of PlayWriting Australia; Literary Manager of Company B Belvoir; curator of the Australian National Playwrights' Conference; and Literary Manager of Sydney Theatre Company. Recent directing credits include Ian Wilding's Rare Earth (NIDA 2011) and Damien Millar's The Modern International Dead (Griffin 2008).

8 David Cuong Nguyen

David is a community theatre maker and award-winning playwright who creates edgy work with diverse and marginalized communities. In 2012 David presented *Black Face White Mask* at Malthouse theatre, to sold out performances and critical acclaim. In 2009 he became Artistic Director of the Arts and Culture program with North Richmond Community Health.

Gideon Obarzanek

Gideon founded Chunky Move in 1995. As Artistic Director his diverse works have been performed in many festivals and theatres around the world. Most recently Gideon has created new works for the Australian Ballet, Sydney Theatre Company and ABC TV. This year, Gideon was awarded a prestigious Creative Australia Fellowship.
